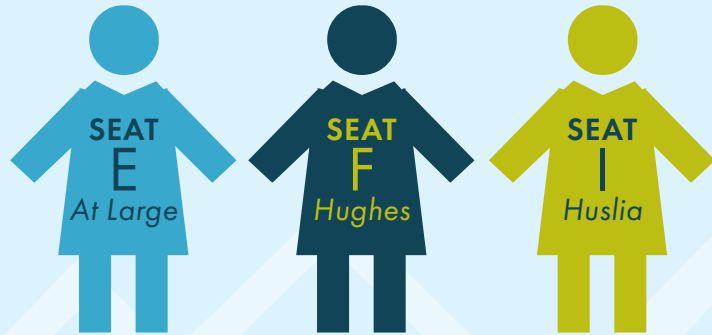

### APPLY BY MARCH 21



We are currently accepting applications for **three open seats** on the K'oyitl'ots'ina board of directors: Seat E – At Large, Seat F – Hughes and Seat I – Huslia. The application period opened on March 1 and will close on Friday, March 21, 2025, at 4 p.m. AKDT. All shareholders age 19+, including our new Class B shareholders, are eligible to apply to serve.

Hard-copy applications have been sent out to the villages and are available at the tribal offices in Alatna, Allakaket, Huslia and Hughes, as well as at the K'oyitl'ots'ina office in Fairbanks.

## OPEN ENROLLMENT IS STILL OPEN!

Open enrollment continues for descendants of original K'oyitl'ots'ina shareholders!

The Class B Stock application and instructions are available to download at [kcorp.alaska.com/openenrollment](http://kcorp.alaska.com/openenrollment).

As the 2025 dividend record day has already passed, new enrollees will not receive the 2025 dividend. However, they will qualify for future dividends.



Class B shareholders whose applications are approved by 12 p.m. AKDT on Friday, March 28, 2025, will have the opportunity to vote at the 2025 annual meeting.

## ENROLLMENT ELIGIBILITY

To be eligible for Class B Stock, new descendant enrollees must:

- ✓ Be a direct descendant by birth of an original K'oyitl'ots'ina, Limited shareholder who received their shares directly from the corporation (not through gifting or inheritance).
- ✓ Be born after December 18, 1971.
- ✓ Have at least one-quarter Alaska Native blood quantum. This can only be established through biological parent(s). It CANNOT be met through adoptive parent(s).
- ✓ Not be enrolled as a descendant in another ANCSA village corporation
- ✓ Be a U.S. citizen.

Additional documents, such as proof of name change, proof of custodianship, paternity affidavit and adoption court order, may be required. If the enrollee is adopted by one or both parents, an adoption form must also be completed.
