

Class B (Descendant) Stock Information

Eligibility Criteria

- ✤ Born after December 18, 1971.
- ✤ One Quarter or more Alaska Native blood quantum.
- * May NOT be enrolled as a descendent in any other village corporation.
- * Child of (including adoptee) of a Class A Original Stock or Class B Descendant Enrollment Stock shareholder.
- ✤ United States Citizen.

Required Documents

 CLASS B APPLICATION – Application is available online at www.kcorpalaska.com/documents *Alaska Native blood quantum <u>CAN</u> <u>ONLY</u> be established through biological parent(s) and <u>CANNOT</u> be met through adoptive parent(s).*

- BIRTH CERTIFICATE An original certified birth certificate is the ONLY document that will be accepted. You can obtain an original certified birth certificate by contacting your local Vital Statistics Office. Birth Certificates will be returned to applicant once eligibility is determined.
- * CERTIFICATE OF INDIAN BLOOD (CIB) or Tribal identification card Proof of blood quantum

An original certified birth certificate is the only document that will be accepted. You can obtain an original certified birth certificate by contacting your local Vital Statistics Office.

Additional Documents, if applicable

- **★** PROOF OF NAME CHANGE if name is **different** than listed on birth certificate.
- ✤ PROOF OF CUSTODIANSHIP if not a biological or adoptive parent
- ✤ PATERNITY AFFIDAVIT if father is not listed on child's birth certificate.
- ★ ADOPTION COURT ORDER if adopted by one or both parents. Documents must show the biological parent(s) name(s).
